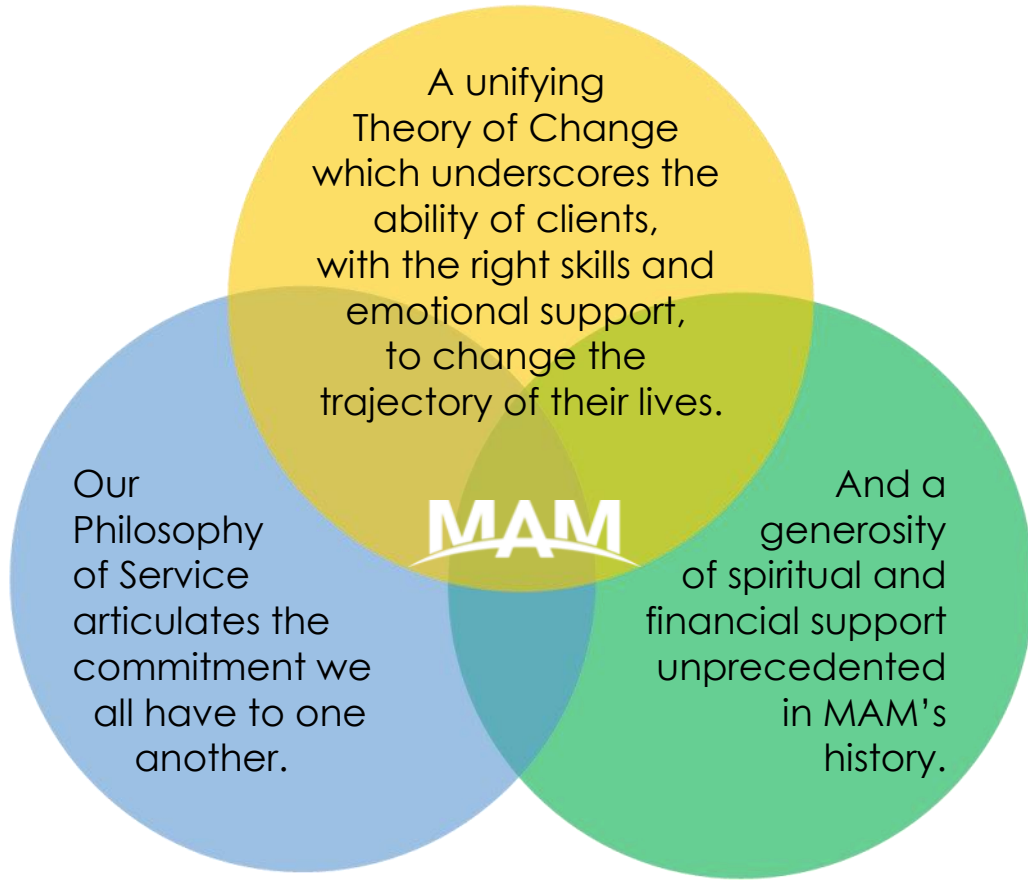

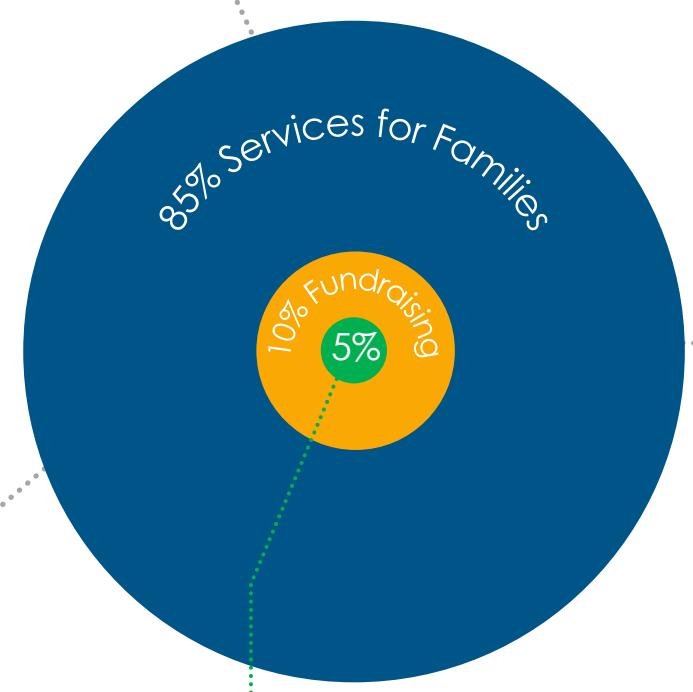

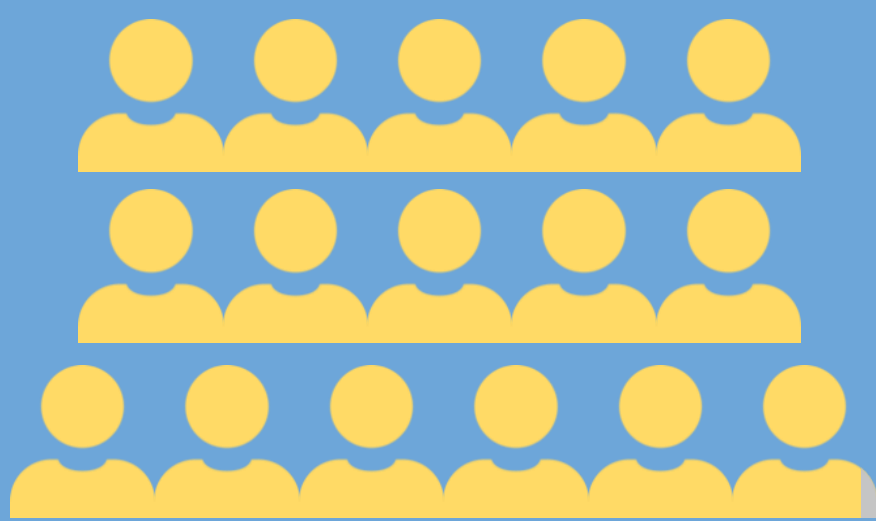
DISTRIBUTION OF FUNDS

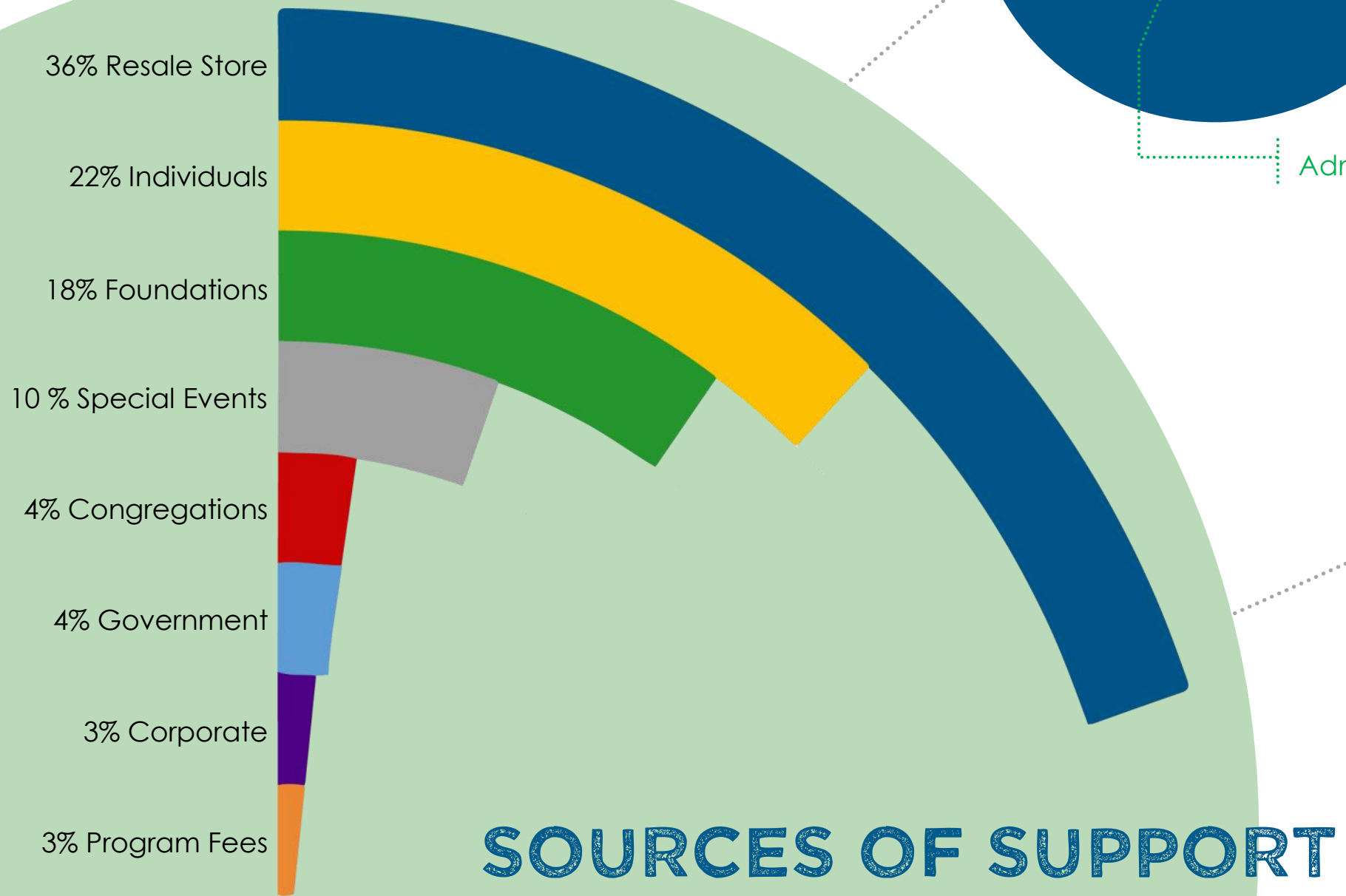
