Stable Families (10,165 served): MAM creates opportunities for families to become financially stable, maintain safe housing, access healthy food and healthcare, and plan for the future. The Pantry Director provides regular updates on the status of pantry activities, trends in food insecurity, numbers served, and new partnerships.

MAM provides emergency financial assistance for rent, mortgage, utilities, and other household expenses to members of the community who report a financial crisis. The scope of services and procedures varies by individual program, but all include gathering documentation from the client to determine identity, home address, and eligibility for services. All payments are made directly to the vendor by check or credit card. MAM employs a variety of means to determine the results of the financial assistance, primarily through follow-up communication to clients and landlords within 90 days of the last assistance payment.
